MAIL

Australia Post is not part of the SCA, so please do not address mail to a persona name. This is confusing to the postal system and can cause mail to be lost. We have enough problems getting the mail through as it is without making it even more difficult. I am talking about all mail not just mail to the herald's office.

LIBRARY ACQUISITIONS

I have been given a copy of the West Kingdom Heraldic Tool, this is a version of the SCA Armorial and Ordinary with entries up to March 1986. Also a copy of 'Early Welsh Genealogical Tracts'. This can document most Welsh names and all the entries are from the 13th century or earlier, however, some modern (16th century) variants are listed.

Would you all please look in second-hand bookshops for copies of Ottfried Neubecker - "Heraldry, sources, symbols and meanings" 288 pages with colour illustrations on most pages about A4 sized and Charlotte Young - "History of Christian Names", MacMillan.

SUBMISSIONS

James Burden the Quester; Politikopolis > new name and device
Or, a scorpion bi-forked to dexter within an annulet Gules.
Name submitted as Burden the Quester, however, no references to Burden as a given name could be found. The device appears to be clear of conflict.

Caitlin O'hArrachtáin; Rowany > new name and device
Argent fretty Sable, on a fess Argent three catherine wheels Azure.
Caitlin is registered many times although no documentation could be found, O'hArrachtáin is the original Gaelic form of Harrington. The device was submitted as Argent fretty Sable, however, this is identical to Brackenbury (Papworth 882), the first alternate of adding a fess Argent charged with three catherine wheels Azure appears clear of conflict.

Edwyn Valon; River Haven > new name and device
The name is documented as a variant of Edwin and vallon is French for a small valley. The device of Quarterly Argent and Sable, a cross recercele voided and counterchanged is in conflict with Eaton (Papworth 618) Quarterly Argent and Sable, a cross patonce counterchanged. There were no acceptable alternates listed.

Eleanor Lyttellhaylles; Saint Bartholomew > new name and device
Vert, an owl and a chief indented Argent.
The name Lyttellhaylles is documented to the mid 16th century, while Eleanor goes back a long way with many historic persons by this name, but no Eleanor's. The device appears clear of conflict.

Louis de la Terre; Dark Skies > device resubmission
Azure, two broken arrows in fess inverted Or armed and fletched Argent.
This is a complete redesign and appears clear of conflict.

Myfanwy of Aberystwyth; Mordenvale > new name and device
Per chevron Argent and Azure, a raven close Sable and a wolf's head couped close affronty all within an orle counterchanged.
Myfanwy is documented from 'Early Welsh Genealogical Tracts' and Younge 'History of Christian Names' and Aberystwyth is a town in Wales. The connective 'of' is English, this style of name is common practice amongst historians. The device appears clear of conflict.

Natalia MacDhonnchaidh; Stormhold > new name and device
Per pale Vert and Sable, two winged stags lodged and wings addorsed respectant Argent and in base a caltrop Or.
Natalia is the submitters given name, MacDhonnchaidh is the original Gaelic of O'Conaghy. The device appears to be clear of conflict.

Phillippa de Lusignan; Rowany > new name and device
Azure, in bend two digitalis purpurea Argent, a chief Or
Philippa dates from at least the 13th century with Philipa, Queen to Edward III (1312 - 1369) and many others in period. 'de Lusignan' is a presumptuous surname, as it is that of the Kings of Jerusalem. One may not use the surnames that imply that one is a member of a Royal family or of Royal birth, hence this name and device are returned.

Reynardine de Clifford; Stormhold > name resubmission
Previous byname of 'of Tara' was ruled to be unacceptable within the SCA. The name 'de Clifford' is that of an baron dating back to about the Norman Conquest. There are many famous people in the family. Sir Robert de Clifford, 5th Baron (1273 - 1314) was an English commander at the battle of Bannockburn and, 'Fair Rosamund' the mistress of Henry II was a Clifford. As Reynardine is to be the first Prince of Lochac and should therefore be a Viscount, this appears that he is presuming the title of the baron. However, the rules of presumption only apply to Royal surnames or direct conflicts with historical people. I and a large proportion of Lochac disagree with this rule as it currently stands. Therefore this is sent to Vesper over many objections.

Vivianne Morgaine de Burgh; Politikopolis > name and device resubmission
Per fess Or and Azure, three decrescents and an acorn slipped and leaved counterchanged.
The name was submitted as Viviane, which is between the documentable forms of the name some of which are out of period. Vivianne is a variant of Vivienne, which is the documentable period rendition of the name, if Vivianne is not acceptable then she will accept Vivienne. The device appears clear of conflict.

Lochac Needleworker's Guild > name and badge
Gules, in saltire two embroidery scissors Or.
This name and badge appears to be clear of conflict.

Order of the Silver Roundel; Principality of Lochac > name only
The name appears to be clear of conflict.

I remain My Lords and My Ladies your servant in Lochac

Maelgwyn ap Gwilym

Resubmission to Kingdom, name and device.

Per pale gules and argent, six crosses crosslet, four and two, counterchanged, and on a chief Or a swan naiant gules.

His previous submission was under the name *Gwydion ap Gwilym*. This name was returned in March XXI, since *Gwydion* is one of the names expressly forbidden by the Rules for Submission.

Both names are given in Gruffudd. *Maelgwyn* is on p.67, *Gwilym* on p.52.

Peter the Uncertain

New, name and device.

Per chevron sable and argent, three goblets inverted, one and two, Or, in base a torteau.

The given name is common; the byname is a TSCA epithet.

The device is close to that registered to Andrew Forres Clegg: "Per chevron sable and argent, in chief three acorns, one and two, Or, and in base a saltire gules". The devices share all the same colors in the same positions, and have the same number of charges. "Complete difference of charge" doesn't apply, and usually we allow only a minor point for the change of type of a charge in base, as it is a change in only part of a group. We made a judgement that the difference between an "isolated" roundel and a saltire which extends to the edges of the lower portion of the field was about as different as one could get, so we shaded the point count a bit. We have invited the College of Arms to comment.

Stormhold, Shire of

Name registered, new badge, see Returns for second badge.

Azure goutty d'eau, a drakkar affronty Or.

This is the shire's registered arms without the laurel wreath.

Tomas Fitzsimon of Oxford

New, name and device.

Azure, a cup Or surmounted by a cross bottony, gyronny argent and sable.

Tomas is the usual form of *Thomas* in several European languages, including Russian, Swedish, Spanish, and English (INS "Foreign Versions of English Names"). *Fitz-Simon* is given as the surname of one of the founding Knights of the Garter on p.358 of Burke's General Armory. *Oxford* is a rather old university town of some repute.

Wulfgar the Bowman

Name registered, resubmission to Kingdom of device.

Per fess azure and Or, a bow fesswise surmounted by an arrow inverted argent, and a sword inverted sable.

His previous submission was returned in July XXI since it included a charge which was very similar to a Staff of Ascepius, which is reserved for qualified medical personnel. This submission substitutes the sword, and changes the position of the bow from bendwise sinister to the more standard fesswise.

Yiannis Damianos Draco

Name registered, device resubmission to Laurel.

Barry Or and sable, a rermouse displayed between three anchors gules.

His previous submission, with gouttes de sang instead of anchors around the bat, was returned by Laurel in October XXI for excessively vampiric connotations -- bat, blood, and the surname *Draco*. This change should make the device acceptable.

Elffin of Mona

Name registered, device resubmission to Laurel returned.

Vert, an oak tree eradicated, blasted, and fructed, in chief an arc of five mullets of eight points, all within a bordure argent.

His previous submission was returned by Laurel in October XXI. In that submission, the tree stood on a mount and was not blasted, and the bordure was Or. Laurel felt that the combination of name and device was unallowable for several reasons. First, the name *Elffin* used with arms so suggestive of the heirs of Elendil bothered many of the commentators. Second, *Elffin* was the name of the individual who Welsh myth gives as the one to pluck the infant *Taliesin* from the sea. *Taliesin* grew up to be a great bard, especially connected with druidic knowledge and the Isle of Anglesey (or Mona). The combination of an oak tree under the summer stars with this name was judged "intolerable". This submission retains all the problems of the previous one.

Argent, on the base of a pall azure, a tower argent, in chief a scythe palewise, blade to dexter, gules.

The device was found to be too similar to the device registered to Ian MacAlister of Lancaster: "Argent, on a pall azure, three daggers proper meeting at the fesspoint. There is a large minor for adding a charge in chief, and another for changing the number, type, and partial color of the charges on the pall, but there are not two points. In addition, charging only the base of a pall in this matter is not good heraldic style.

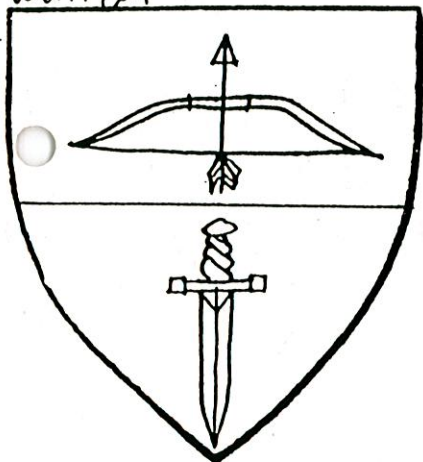
Stormhold, Shire of

Name registered, new badge returned.

Azure, a drakkar affronty Or.

As drawn, this is in visual conflict with the arms of Bartrum: "Azure, an escutcheon Or" (P685). The drakkar is drawn in such a way that the sail comes fown and meets the hull, forming a shield-shaped charge. (See the mini-emblazon of the Stormhold badge which was passed for an example of the emblazon style.) If the drakkar is drawn in a more normal manner, the submission will be reconsidered.

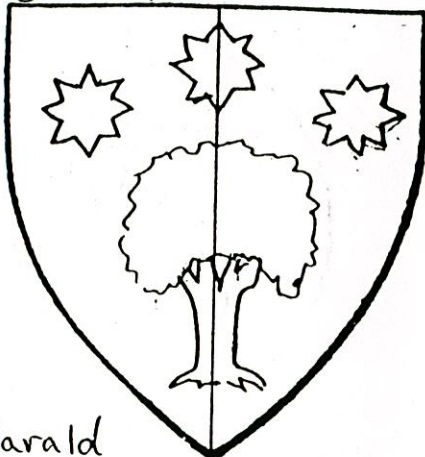

Beornoth of Filey

New, name only.

Beornoth is given on p.102 of Searle's Onomasticon Anglo-Saxonicum, as a variant of *Beornnoth*, which appears 21 times. *Filey* is a town on the NE coast of England, just south of Scarborough.

Colin de Charteris

Name submitted December XXI, resubmission to Kingdom of device.

Vair, an estoile gules surmounted by a chevron inverted Or.

The surname is derived from the French cathedral town of Chartres. Black (p.147) gives under *Charteris*: *de Carnoto, de Cartres, de chartres, Charteris, d'Chartris* all occurring in period. We feel that *de Charteris* could be added to this list as a reasonable variant, and have updated the information given in the February LoI.

His previous submission was in February XXI, and was essentially the same but drawn in a non-heraldic manner. He has corrected the emblazon.

The submitter used vair ancient on his forms, but we feel that the specific type of vair used can be left to artistic license.

Gareth of Greymarch

New, name and device.

Per pale azure and Or, a tree eradicated and in chief three mullets of eight points, one and two, all counterchanged.

Gareth is the name used by Malory for one of Arthur's knights, and was given to an English child baptized in 1593 (Withycombe, p.125). *Greymarch* is constructed of common English placename elements.

Harald of Sigtuna

New, name and device.

Per pale azure and Or, an albatross displayed, wings inverted, argent, all within a bordure counterchanged.

Harald is given on p.11 of Bassi's Old Norse Name. *Sigtuna* is a town in Sweden. The Encyclopaedia Britannica does not connect any of the Norse kings named Harald with the town of Sigtuna.

This design is his third alternate. His original design, "Barry Or and azure, an albatross displayed, wings inverted, argent" was found to be too similar to the registered device of Dovanna of Atenveldt: "Azure, a dove wings displayed and inverted argent, perched upon an olive branch fesswise proper". His first alternate, counterchanging the field per pale, does not remove the conflict. His second alternate, using an azure field with an Or bordure, does not remove the conflict.

The albatross was originally blazoned as "proper", but the only "colored" parts of the bird were the wingtips, which were a sort of "charcoal argent". We felt that this could be left to artist's license.

Leofric of Mona

Name registered, resubmission to Kingdom of device.

Purple, on a pale between a decrescent and an increscent Or, a pale vert, a chief argent.

His previous submission was made in February XX and was returned for conflict. This is a complete redesign.

This is his second alternate. His original design, without the chief, was judged to be too similar to the device registered to William of Blackmoor: "Purple, on a pale between two double-bitted axes Or, a sword purple. His first alternate, adding a frog tergiant Or in sinister base, was rejected because it was unbalanced and not heraldic in style.

Melloney de Charteris

New, name and device.

Vair, a two-towered castle gules with wooden gates proper, on a chief azure, two estoiles Or.

The given name is a spelling variant of *Melanie*. Withycombe (p.217) cites it as appearing in Devon or Cornwall in 1655 in this form, so it may have been used earlier. The name comes from the saint's name *Melania*, held by a Roman grandmother and granddaughter who were devoted to St. Jerome. If *Melloney* is found unacceptable, she will accept *Melania*.

The surname is derived from the French cathedral town of Chartres. For further information, see the submission of *Colin de Charteris*, above.

The central charge was originally blazoned as a "gatehouse", but it was changed to "castle" to reflect visual reality. The only difference between this and a standard castle is that this drawing does not have battlements. Boutell (p.94) gives "gatehouse" as a castle with a larger-than-usual door.

Catherine Elspeth d'Aix la Chapelle. Name only (see RETURNS for device).

The name was submitted as Catherine Elspeth d'Aix La Chapelle. We have corrected the form of the place name to the normal orthography as permitted by the submittor.

Innilgard, Barony of. Badge. Azure, on a goblet argent, a fret coupé gules.

Michail Viralier. Name and device. Argent, a cross gules surmounted by a seahorse erect, maintaining a sword palewise, in sinister chief a mullet, all within a bordure sable.

Rhiannon of Starfire Retreat. Device. Per bend wavy sable and purple, a bend wavy Or, in chief a compass star argent.

Wulfsige Clovenhaft. Name only (see RETURNS for device).

Catherine Elspeth d'Aix La Chapelle. Device. Argent, a Latin cross coupé azure surmounted by three pallets sable, all within a bordure gules.

There was a general consensus that the three pallets made the underlying primary charge unrecognizable, the more so since the sable of the center pallet faded into the azure of the cross, thus blurring the outline. Using two pallets placed in a position that would allow identification of the primary charge or possibly substituting bendlets or scarps would resolve the problem.

Wulfsige Clovenhaft. Device. Argent, a felling axe bendwise sinister, blade to chief, debriused by a bend within a bordure, all sable.

Unfortunately, the precedent in this case appears to be the badge of Albert von Drechenveldt which was returned in December, 1985, for appearing to be a "no outhouses" symbol. Since the tincture of the ordinaries in that case was Or, evidently the use of gules is not a consideration. Note also that in the Discouraged Practices section (X3) merely specifies "the bend-plus-bordure 'no X' motif". That this is a design that well could have existed in period (and show cadency from a family which bore "Argent, an axe bendwise sinister sable.") is rendered irrelevant by the problems raised by the essentially twentieth-century perceptions of the majority of the membership. My feeling, however, is that rendering the bend and bordure in different tinctures would remove the visual suggestion of the "no axes" sign and thus resolve the problem.
