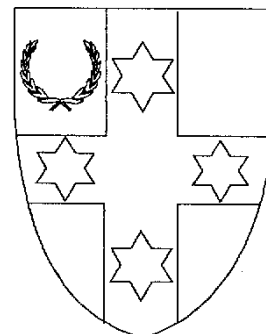

A Reminder to Local Heraldry

If you haven't already written it, your tri-annual report for the period January to April 1991 is due NOW! I've already received a report from Agaricus and River Haven, who get Gold Stars.

Announcements

Firstly, concerning the May Coronet Investiture:

My Lord and Lady Heraldry of Lochac, I am writing to you about the forthcoming Coronet Tourney and Investiture to be held in Aneala in May.

Aneala is a relatively small group, and we have only a small number of experienced Heraldry. Many of them are likely to be fighting in one or other of the Tourneys that weekend, and so will be of necessarily limited help, heraldically. For this reason, I am hoping that any Heraldry from the rest of Lochac will be able to assist in the Court, Duty and Field Heraldry during the event. Lord Crux has told me that he will be attending, and he will therefore be running the Principality Courts. However, he will require

assistance for this. I *would* be able to do this, but I am still responsible for the *rest* of the Heraldry. To be brief, we need assistance from any Heralds or Herald-groupies who will be there.

If you will be visiting Aneala for May Coronet, and you are willing (you don't necessarily have to be *able*, just willing to learn quickly) to assist with the Heraldry, please ring me (or preferably *write* to me - and you'll find it *much* cheaper (even a postcard would be fine)) and tell me what sort of Heraldry (Court, Duty or Field) you wish to do, and what times you will *not* be available (preferably tell me what events you wish to attend; I can then work around program changes). With this information I can then create a Roster for the event, and everything will go much smoother than it might otherwise. (I am not going to detail the program for the weekend here; you should have received one with your information package that you received after booking. You haven't booked? Do it NOW!)

While more tangible rewards are beyond my ability, your labours will not go unrecognised (unless, of course you *wish* anonymity) and Lochac, Aneala and I will remain forever in your debt.

Finally I remind you of the mini-Collegium to be held in Stormhold on the weekend of June 8-10. One day, the Saturday, is to be dedicated to "heraldic things". If you are willing/able to attend and present a paper or chair a discussion, please let me know ASAP.

Roster Changes

The vacant offices of the College of Blessed Herman the Cripple (Innilgard), and the Canton of Parvus Portus (River Haven), have both been filled. The new P.E. for the former is Lord Kenelm de la Dale [Ken Howard], 27 Belford Avenue, Devon Park, SA 5008. Telephone (08) 346 3944. As Lord Kenelm was already a P.E.-at-large, he will be rostered as P.E. for the College. And for Parvus Portus, the new herald is Kara of Kaithmonnorra [Ra'chel Hall], 5 Warrel Street, West Ipswich, QLD 4305. Kara will be rostered as acting P.E. for the Canton.

In the Barony of Aneala, Master Sir Peter du Gant Noir [Peter Fryer] has decided to return his roster letter after all, so he is reinstated to his former position of P.E.-at-large.

Welcome to your new positions in the College of Heralds, one and all!

The recent appointment of Lord Sulaimon Rolando Cordobes to the office of herald for the Shire of Politarchopolis appears to have been premature. As he has failed to return a signed roster letter, or indeed replied to any of my correspondence to him, the office is once again vacant. And the Colleges of St. Aldhelm and St. Ursula are *still* without heralds, and their respective seneschals will soon be receiving stern letters.

The acting Black Wing Pursuivant, Lord David de Saxby, has changed his postal address. It is now c/- David Ferstat, PO Box 237, West Perth, WA 6005. (Telephone is unchanged.) The acting Cinquefoil Pursuivant, Master Sir Richard de la Croix, has changed *his* address also. It is now c/- Richard Krajewski, 7/7-11 Stokes Street, Lane Cove, NSW 2066. Telephone (02) 428 3767. And Lord Dubhghlas Mac Ailean, PE-at-Large, has moved as well. No longer in Innilgard, he can instead be found in the Shire of Agaricus: Alan Hosie, "The Menagerie", 61 Sorrell Street, North Parramatta, NSW 2151. Telephone (02) 630 7401.

In the Barony of River Haven, Lord Wulfstan of Broxton has told me that the incipient Canton of Huc Draconae actually wish to be known as Adesse Draco, and that is the name that they will be submitting. (Petition-signing is apparently in progress.)

Incipency

In his recent "To All Officers", the Principality Seneschal, Master Sir Peter du Gant Noir, directed a notice to all of Lochac's groups that are still "incipient" - particularly the ones that have been around for some time. To quote him directly, "move it or lose it". Well, if you are the herald for a group that fits this description, do you realise that your group *must* remain incipient until your group's name is registered? Do you also realise that dragging your feet over this matter is as good an indication as any that your group really doesn't have what it takes? Is this a hint? You betcha.

Incidentally, if your group's name (and preferably device as well) *is* registered, but it is still incipient, than as a local officer you should be hassling your seneschal to find out the reason why.

Out of the Mouths of Principality Herald's . . .

. . . sometimes comes the most astonishing rubbish. In last month's *Camel*, I made the following statement:

Rumour has it that Pursuivants are "entitled" to use a cloak instead of a tabard, but I have yet to see documentation for such practice, and *I* certainly don't want to promote such rampant snobbery.

Ahem. Well, "rumour" turns out to be the *West Kingdom Herald's Handbook*, Section III.3, "Heraldic Regalia And How To Wear It". It quite clearly lists there the preferred dress for heralds of various ranks. So the "rampant snobbery" I was worried about is in fact West Kingdom Policy. I might add that it *is* pointed out that they are guidelines only, not rules that must be enforced. There's a moral or two in this . . .

Further to this discussion, Lord Peter the Uncertain has this to say:

I usually take my cloak to events, and if there is no tabard available I don't hesitate to lend it to PEs or cornets, but I prefer it if they wear the appropriate garb for their rank. Is that snobbish? Pursuivants are supposed to know more, have more experience, and be examples of correct heraldic conduct. An example is more noticeable if it is distinctively garbed. Again, if I see a baldric on a herald I know he is inexperienced, so I reduce my expectations and maybe very diplomatically offer advice or help.

And Seigneur René du Bon Bois, acting Frette Rouge Pursuivant, agrees:

The title of pursuivant is, like most titles in the S.C.A., one earned through much devotion and hard work, and there should be some means of differentiating between one such as this and someone who, for example, "only does a bit of duty work when they absolutely have to". Besides, it is a *feudal* society we are recreating here.

Well, they certainly have a point. I suspect that this is the reason for the "different garb for different ranks" idea in the first place. Just remember, *the* most important thing is the device being displayed, not the cut of garb that it's being displayed on!

As a more general comment for discussion, Lord Peter raises the following point:

I read Pedair's comments in the March *Camel* with interest. I agree that more pageantry from officers would greatly enhance the atmosphere of events. Unfortunately, heralds cannot wear their tabards or cloaks casually. A herald in uniform is a herald on duty, and heraldic regalia cannot be worn unless you are on duty. Otherwise, you have a dozen people all being asked to do announcements, which is chaotic. You also have to act with heraldic reserve and decorum while in regalia, which really limits your fund of gossip and small talk. What I think we need is some form of 'heraldic undress' which says in effect "Yes, I'm a herald, but I'm not on duty." I am proud to be a herald. I think we all are. I would like some way of showing the flag, so to speak, at ceremonial events. Seneschals can wear a key wherever they go. A & S officers and reeves have tokens or badges they can wear any time. Officers like heralds, marshals, surgeons, and constables, however, are either on duty or invisible.

A very good point indeed. It is possible to purchase little stick-pins with the badges of the various offices displayed on them - a number of heralds and marshals in Stormhold, at least, have them. Whether they're prominent enough to serve as the 'flags' that Lord Peter would like to see is debatable, but it's a beginning. In addition, I don't see why you can't make a small cloth patch of the particular office badge you want and attach it to your garb. As long as it's not too big it shouldn't be mistaken for a claim to be "on duty". Of course, unless you just pin it on, it's not exactly mobile. Does anyone have any other suggestions for this problem?

Seigneur René agrees with my comments on material for tabards, noting that if we adopted Pedair's suggestion for different material for different ranks, it would "mess up an already satisfactory state of affairs" in Innigard. He further adds:

I also believe that each group, especially the Baronies, should have at least one specky tabard for courts and to show off for when Royalty come a-visiting. There is certainly nothing wrong, in my opinion, that personal regalia be showy - after all, our job is to provide information, and the more visible you are, the more notice people will take care of you.

As long as we stop short of day-glo tabards and flashing lights.

As of the time of writing neither the West Kingdom *Minutes* for March nor the Laurel *Letter of Acceptances and Returns* for March have arrived in Lochac.

Meeting Schedule

Every month, the Crux Australis Herald holds a meeting to consider the heraldic submissions from around the Principality. These meetings are usually held at 4 Max Court, Noble Park VIC 3174, on Saturday afternoons, beginning at 2.00pm and continuing until we're done. The Hund Herald, Master Thorfinn Hrolfsson, holds weekly meetings to comment on submissions from around the Known World. These meetings are almost invariably held Monday nights beginning at 8.00pm at the home of Lord Thrainn Járngímsson [Stefan Akerblom], 'Fjordhalla', 7 Glenlea Close, Rowville VIC 3178 (phone (03) 752 8458). Regular commentary is also taking place in Innilgard [Adelaide], Llyn Arian [Lake Macquarie, NSW], River Haven [Brisbane], Ynys Fawr [Hobart], and now Arx Draconis [Swan Valley WA] as well. This Month's Submissions

The April meeting of the College of Heraldry in the Kingdom of the West in the Principality of Lochac was held on the afternoon and evening of 13 April at the home of the Crux Australis Herald. As I was the only person to show up, the meeting progressed somewhat more slowly than usual. On the other hand, differences of opinion were few.

The following conventions are used: CVD means a "Clear Visual Difference", as defined in the *Rules for Submissions*, or *RfS*; books cited without further details are in the Bibliography (see p.9).

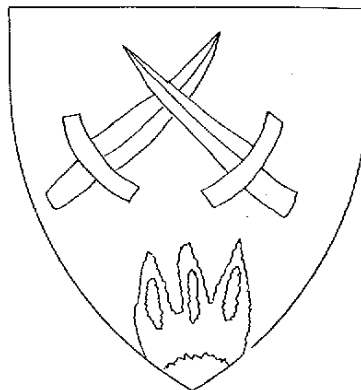
1. Aidan of Sicily (New Name and Device; both SUBMITTED) [St. Christina]

Vert, two daggers in saltire argent and issuant from base flames of fire proper.

Aidan can be found in Withycombe, p.7, deriving from the Old Irish *aid*, 'fire'. It was the name of a 7th Century monk of Lindisfarne. The submitter is aware that it is normally a male name. The byname is common English; the island of Sicily has been occupied by humans for at least 10 000 years, according to the *Britannica*, and the name has remained essentially unchanged throughout history.

The device appears free of problems.

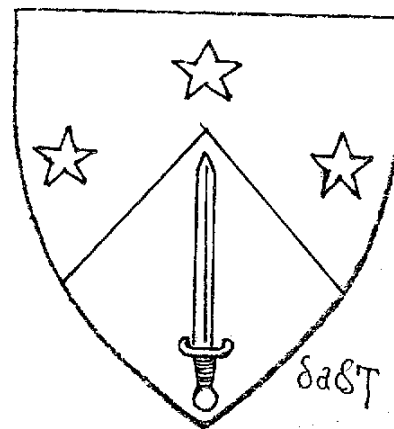
2. Alfar of Attica (New Name and Device; both SUBMITTED) [Rowany]

Per chevron sable and gules, three mullets, one and two, Or, and a sword palewise proper.

Alfar was submitted as an alternate spelling of the of the Old Norse *Álfr*, meaning 'elf', found in Yonge on p.380 and Bassi on p.8. This argument would normally be a bit difficult to justify, as that final 'r' is silent. However, in the Crux library, the book *Norsk-Isländska Dopnamn* by E.H. Lind (Uppsala, 1915) does give on p.14 *Alfar* as a variant of *Álfr*, and furthermore dates it to the 13th Century. *Attica* is the ancient Greek state of which Athens is the chief city.

The submitter's first choice of device, *Sable a sword proper, and in chief three mullets one and two Or*, conflicts with the mundane arms of Dymock: *Sable, a sword in pale argent, hilt and pommel Or* (Papworth, p.1103). There is only 1 CVD, for adding the mullets. His second design seems free of problems.

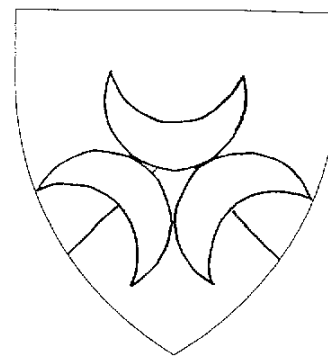

3. Austyn of Forrestgate (New Name and Device; both SUBMITTED) [Blessed Herman]

Per chevron sable and gules, three crescents conjoined in pall inverted, horns outwards, Or.

Austyn can be found in Withycombe, p.36, as an English name derived from the Latin *augustus*, 'venerable'. This spelling is dated to 1379. The submitter asserts that *Forrestgate* is a 'town on the edge of Hanault Forest in England' but did not provide any documentation; I could not find either the town or the forest in any of my sources. Still, it does not seem unreasonable as a constructed placename. Ekwall, p.193, notes the use of the Middle English word *gate*, 'road', in a number of placenames - and there were certainly plenty of forests in England in period. I imagine quite a number of them had roads as well.



The submitter's first choice of device, *Sable, three crescents conjoined in pall inverted, horns outwards, Or*, is in conflict with the mundane arms of Hovell: *Sable, a crescent Or* (Papworth, p.594). There is only 1 CVD, for changing the number of crescents. His alternate seems free of problems.

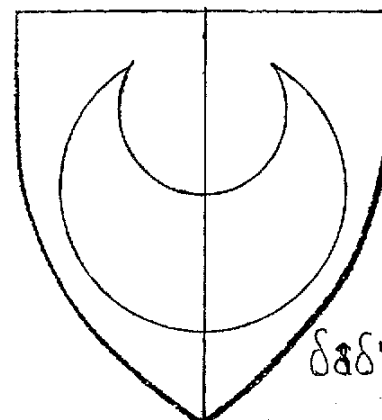

4. Daniel the Willing (New Name and Device; Name SUBMITTED, Device RETURNED) [River Haven]

Per pale argent and azure, a crescent counterchanged.

Daniel is Biblical, of course, and often used in England in the 12th and 13th Centuries, according to Withycombe, p.78. *the Willing* is common English.

The device is simply beautiful. Unfortunately it is in conflict with the registered S.C.A. device of Durien of Glarus: *Per pale argent and azure, in bend three crescents counterchanged* (Nov. 82). There is only 1 CVD, for changing the number of charges. The submitter did provide an alternate, which seemed free of conflict at first glance, but he also ticked the 'make no changes' box - which means I can't submit his alternate. So it must be returned. [Please see *Vesper's* comments on the 'make no changes' box in last month's *Camel*.]

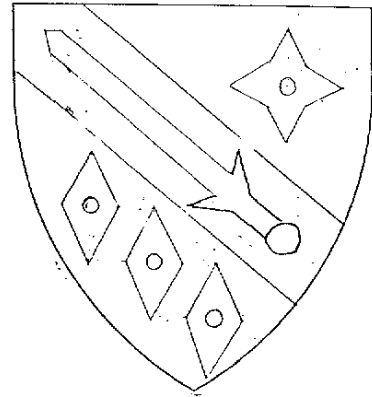
5. **Eric Alard** (Device Resubmission to Laurel; SUBMITTED) [Innilgard]

Azure, on a bend argent between a mullet of four points Or, pierced, and three rustres argent, a sword azure.

Eric's name was registered in November 1990. His previous device submission, the same as this one but without the sword, was returned by Lord Laurel at that time for conflict with the arms of Benton: *Azure, a bend argent*. There was only 1 CVD, for adding the charges around the bend.

Adding the sword seems to have done the trick; I couldn't find any conflicts. Unfortunately it hasn't improved the device any - it would be immeasurably improved by making the charges around the bend all the same type and tincture - but this is a case for HYNAP - Hold Your Nose And Pass it.

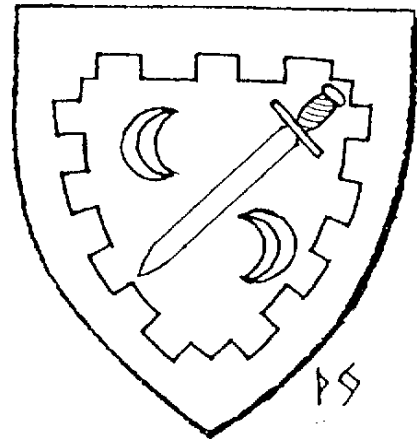
6. **Iain James MacLaren** (Name and Device Resubmission to Principality; both SUBMITTED) [Rowany]

Azure, a sword inverted bendwise sinister between a decrescent and an increscent, a bordure embattled, all argent.

This gentle's previous name submission, *Iain MacLaren of Tiree*, was returned by Crux Australis in December 1990 for conflict with John MacLaurin, chief of the MacLaren clan of Tiree. By dropping the reference to Tiree, and adding the middle name, the conflict is well cleared - and it's still a fine Scottish name.

The device, as before, seems free of conflicts.

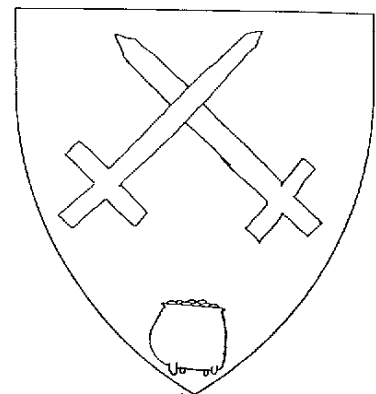
7. **Isaac of Damascus** (New Name and Device; both SUBMITTED) [St. Christina]

Purpure, two swords in saltire argent and in base a pot of gold Or.

Isaac is a Biblical name. *Damascus* has existed for a long time; the submitter provided evidence from *The Oxford Illustrated History of Medieval Europe* (G. Holmes, OUP, date unknown) to show that it existed in at least the 9th Century, and I daresay that it is much older than that.

The device seems free of problems. As far as I was able to determine, there is no heraldic "pot of gold" defined, but I couldn't think of a way to blazon it more precisely without making the overall blazon very clumsy; and I think that the intent is clear enough not to worry about it.

8. **John Blackwood** (New Name; RETURNED) [River Haven]

John is a Name That Needs No Documentation. The submitter asserts that *Blackwood* is a coined name, but it can in fact be found in Reaney's DoBS, p.37, where it is dated (in various spellings) to 1327. It's a fine English name. Unfortunately someone has beaten him to it - the name *John of*

Blackwood was registered in March 1987. The submitter's permitted alternate, *John of the Black Wood*, does not really clear the conflict. He will be advised of some simple changes that he can make that should fix up this problem.

9. Martin Chaucer (New Name; SUBMITTED) [St. Christina]

Martin can be found in *Withycombe*, p.210, and is of Latin origins; St. Martin of Tours was a 4th Century soldier, and became a very popular saint in England and France. *Chaucer* is of course the surname of the famous 14th Century poet, writer of *The Canterbury Tales*; but it was by no means unique to him. Reaney's *DoBS* lists several period examples on p.71. Apparently the name derives from a maker of leather boots and breeches. In short this is a wonderful name.

10. Riccardo di le Torre D'Avorio (New Name; SUBMITTED) [Adesse Draco]

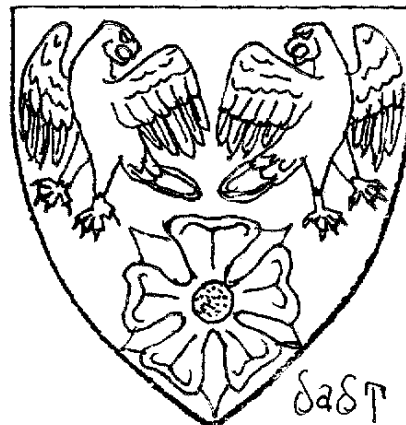
The name is intended to be Italian for "Richard of the Ivory Tower". *Riccardo* is one of many Italian versions of the name "Richard"; the submitter provided documentation to show that it was in use in the 13th Century, at least. My Italian dictionary confirms that *Torre* is the correct Italian for "tower" and *D'Avorio* is correct for the adverbial form of "ivory", but I have not the faintest idea whether the grammar is correct. The submitter has permitted grammatical fixes to preserve the meaning so I'm sure that any problems with the grammar will be fixed at either Kingdom or Laurel level.

11. Susanna of Nottingham (New Name and Device; both SUBMITTED) [Rowany]

Sable, two eagles passant regardant addorsed, wings displayed inverted, and a rose argent.

Susanna is from the Hebrew for "lily", and can be dated in use in England (with this spelling) to 1200 AD (*Withycombe*, p.273). *Nottingham*, famous for its forest full of anti-socials, is also an English city dating back to at least the 9th Century. Originally named *Snotengaham*, "the village of Snot's people" - Snot being a name found in the *Domesday Book*, Anglo-Saxon for "wise". The dropping of the *S-* was apparently due to Norman influence, and one can hardly blame them. If you don't believe me, look it up in *Ekwall*, p.345, or *Reaney's OoEPN*, p.199.



The device had me thinking for a while. Is an "eagle passant, wings displayed", worth a CVD from a plain old "eagle displayed"? (The position of the heads and the wingtips are irrelevant.) The only change is the orientation of the body and the tail. If it is *not* considered different, then the device is in conflict with the arms of *Barantyne et al: Sable, three eagles displayed argent* (*Papworth*, p.326). There is only 1 CVD, for changing the third eagle to a rose. The submitter's permitted options, changing the tincture of the birds and/or rose to Or, either don't clear the conflict or bring up a new one: *Sable, three eagles displayed Or* (*Dru de Barantine et al, Papworth*, p.326). If there is not a CVD for the orientation of the birds.

In the end I couldn't make up my mind, so I am submitting the device to obtain *Vesper's* opinion.

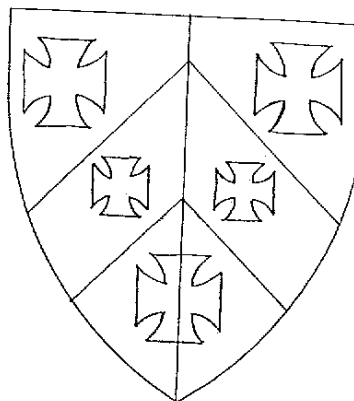
12. William of Wakefield (New Name and Device; both SUBMITTED) [Innilgard]

Per pale Or and gules, on a chevron between three crosses formy, two crosses formy, all counterchanged.

William is another Name That Needs No Documentation. *Wakefield* is the name of two English towns, the most famous being that in the West Riding, 'home' of the Wakefield Plays (a collection of medieval mystery plays).

The striking device is quite unified in its design, and appears free of conflict.

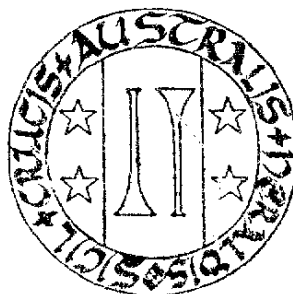
Lochac Roster of Heralds
