Submission Details: Language: English This submission was submitted with only one name form, this should have been a cause for return but I was nice this time and I photocopied the name form. Please remember 4 names (including documentation), 5 devices, and 4 badges.

The name s interesting in that [3] states "..., a common name amoung the Jews, but not used as a chirstian name in England until after the Reformation." Does this mean that the Jews used it in period or that it is common now. All this aside seeing as it apears in the Bible and is meaning 'ewe' is consistant with Jewish naming practises, and that the Reformation is in period, it seems plausable that this is acceptable. The epitet the Untamed seems T.S.C.A. but untamed dates to 1340 in the OED and [2] on p 258 gives examples of un-names, including Unwin meaning unfriendly, Unred (1208-13) meaning taking no counsil, Unnredy(1334) and Unskole c1200 probably meaning without learning or in my opinion without schooling and a few others, it seems that this name would be better as Rachel Untamed but apart from that not as bad as it first looked.

The device whilst devistatingly simple seem clear of conflict.

The Falconet is documented from the Columbia-Lippencott Gazetteer as the pre 1630 name for Folkingham but no evidence of this can be found because I cannot look at the Gazetteer as I don't have one and the photocopy does not sustain the arguement.
