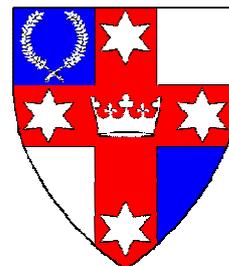

From Herald in Charge of Rowany Festival:

From Padraig Lowther, by Royal Warrant Cinquefoil Pursuivant, to the College of Arms of the Kingdom of Lochac, Greetings.

As happens every year, Rowany Festival is rapidly approaching the point where it is ACTUALLY only 2 weeks away, and so those of us who are attending are madly finishing off projects and finalising our plans. Part of this for me is ensuring that there will be sufficient heralds present at Festival to fulfil all of the duties requiring heralds.

As such, I am looking for volunteers to assist me in this. I have already had a great response, including from some relatively new heralds, but the more people we have sharing the load, the easier it is for everyone. This is especially true considering just how much is on at Festival this year.

The duties that Festival needs heralds for include:

For those considering bidding on the 2012 Known World Heraldic and Scribal Symposium, the deadline to have your bid entered into OSCAR is May 15, 2011. This will give the College of Arms time for consideration so that we can announce the bid's award at this year's KWHSS in Atlantia, as is our preferred practice.

Please remember that bids posted to OSCAR are publicly readable. Because of this, all personal information, such as legal names, addresses, phone numbers, and email, should not be included in these bids without signed, written permission. Such information as is necessary should be posted as a comment after the bid is finalized, so that only the College of Arms can read it. As a reminder, there is a KWHSS domain and web hosting space available on the SCA's servers; you need not register your own.

From Laurel: A Gentle Reminder Regarding Petitions

There have been a few issues lately regarding petitions for branch names and armory, in some cases rendering the petitions invalid. We would like to remind everyone of what is required for a valid petition and when petitions are required.

As is described in the Administrative Handbook IV.C.5. Evidence of support, a valid petition must include on every page of the petition, both a clear description of the item(s) being submitted and the date. For armory, either the emblazon or blazon is acceptable, though including both is preferable.

Petitions are required by the Administrative Handbook for the branch name and the branch arms alone. They are not required by Laurel for award and order names, badges, or other items.

From Pelican: Some Name Resources (A Series)

We've talked about online dictionaries for English, Old Norse, and French. Unfortunately, there is not an equivalent online dictionary for Spanish. What there is, however, is almost as useful (if you can read a little Spanish). The Real Academia Española has a collection of historical documents, which form a database of historical usage. It's called CORDE (Corpus Diacrónico del Español) and is found at <http://corpus.rae.es/cordenet.html>.

The word that you want to find goes in the search box labeled *Consulta*. Put 1600 (or 1650) in the second space in the second of the two boxes labeled *Cronológico* (which limits the citations to before that date). Click *Buscar*. That will bring up a group of cases (the number is listed as *casos* under *Resultado*). To get the actual examples (for context), click on the button labeled *Recuperar*. If the number is under 1,000 or so, the system defaults to giving the sentence from the original document, listed as *Concordancias*.

If there are too many examples, you can't get to the *Concordancias* directly. Instead, the system will bring up a list of documents. You have to select documents (you can select several at a time), then change the drop-down box from *Documentos* to *Concordancias* and click *Recuperar* to get the citations.

You'll need to include the information you get here with any submission, as the search doesn't generate a permanent URL. For example, a search on *Leonor* gives 253 cases in 27 documents before 1650. A 1553 document describes *los dichos licenciado Çerbantes e doña leonor de torreblanca* ('the said licenciado Cervantes and Doña Leonor de Torreblanca').

Submissions

Copies required:

NAMES: Two (2) copies of both the form, any permissions to conflict and ALL documentation, including title page of each book **NB: The title page is not the same as the book cover!** Persona essays may be entertaining, but do NOT constitute documentation. When citing web sites as documentation, you must include a printout of the relevant pages.

DEVICES AND BADGES: Four (4) colour copies and one (1) black & white OUTLINE copy. Three (3) copies of any additional documentation or permissions to conflict. The colour copies should be accurately coloured, preferably in texta. Unacceptable methods of colouring include colour printing or photocopying, crayon, faint pencil, and gel pen.

Please include **ALL** necessary documentation to support each submission. It is the responsibility of the submitter to present their submission in a way that makes registration easy. Name documentation should be as accurate as possible. Failure to provide sufficient documentation is a cause for return. If you are having trouble with your documentation speak to your local herald. If they can't answer your specific question, consider writing to Blazons, posting in the Basilisk forums or contacting me. Please don't staple your forms; paperclips are fine and loose is better.

Aoife inghean Uí Chonchobhair - New Name

Submitter desires a feminine name.

No major changes.

Language (Unspecified, presumably Gaelic) most important.

Submitted as Aoife inghean Uí Chonchobhair, the byname has been lenited as required by Gaelic grammar.

Aoife - From the May 2010 LoAR [Aoife inghean Tuathail, Ansteorra-A]:

Two women with forms of this name are dated to 1166-1173 and 1227 in "Index of Names in Irish Annals: Aífe / Aoife" (<http://www.medievalscotland.org/kmo/AnnalsIndex/Feminine/Aife.shtml>). Additionally, Colm Dubh "The Ban-Shenchus: A Dated Index" (KWHS, 2003) lists 5 women with this name.

inghean Uí - Gaelic for "daughter of the clan of" per St Gabriels report 1344 (<http://www.s-gabriel.org/1344>)

Chonchobhair - Lenited genitive of masculine given name Conchobar.

Per pale and per chevron argent and azure, three bees counterchanged



Leonor de Alcocer - New Device

Per pale gules and azure, a pine tree Or between in chief two lilies inverted and on a chief triangular argent a mullet azure



Kingdom level returns:

Bili of Twyford - New Name - Returned for lingual and temporal inconsistency and insufficient documentation

This submission did not include any documentation or summary for the byname, and a summary with no attached photocopies for the given name.

Bili was described on the form as the name of a 7th century King of the Picts. Kingdom commenters were able to document Twyford as a 13th century place name. This means there is at least one Step From Period Practice for mixing Pictish and English and one SFPP for a temporal gap of over 300 years (but less than 1000 years) between name elements. A name is only registerable with one or fewer SFPP and so this must be returned.


While the submitter requested a feminine name on the form, commenters noted that documentation for Bili was only found as a masculine given name.

A resubmission should include printed or photocopied documentation for all name elements, summarised on the form.

Bili of Twyford - New Device - Azure, in fess three herons, heads erect argent - Returned for redraw

No commenter was able to determine what the charges were without reading the blazon. Under Section VIII of the Rules for Submission, armorial elements must be clearly identifiable at a distance.

A resubmission should include feet, internal detailing and a standard heraldic posture to aid recognition.




Thomasina Mariscotti - New Device - Per fess argent and argent fretty azure, in chief a violet azure - Return for conflict

In period heraldry, fretty was considered interchangeable with a fret. Therefore, under the alternate blazon <Argent, in pale a violet and a fret azure>, this submission conflicts with the below, with only one CD for adding the fret(ty):

Alyanora of Vinca

Either the name or the following device associated it (or both) were registered in February of 1975 (via the West): Argent, a periwinkle [Vinca minor] proper.



This branch name was an appeal of a previous Laurel-level return.

The submitters demonstrated several facts about the construction of names in German, but none support the addition of *-feld* to an existing placename. They demonstrated that some elements were used both to create monothemic names (like *Bern* and *Muhl*) and as the first element in dithemic names (like *Berndorf* and *Muhlbach*). But this pattern does not demonstrate that all placenames may be treated in that way. We would need evidence of *Aachen-* with other deuterothermes attached in order to accept this argument.

The submitters assert that *aach* is a variant of the attested *-bach*, but present no examples that support their argument.

There is a modern place, *Aachtopf*, which could, if period examples were found, support *A(a)ch-* as an element, but that example would support a constructed *Aachfeld*, not *Aachenfeld*.

Unfortunately, the submitters have not made a case that *Aachenfeld*, as opposed to something like *Aichenfeld* (suggested in the previous return), can be registered. Therefore we are forced to return this submission again.
