## SUBMISSIONS

Hrolf Herjolfssen; name registered device resubmission Quarterley Sable and Or, a sun with the cardinal points extended throughout, within twelve roundels in orle counterchanged. This device appears to be clear of conflicts.

Reynardine of Tara; name at Laurel new badge submission Per pale Vert and Purpure, a windmill sails set in saltire Or. This badge was researched by Eilis O'Bourne of the Kingdor College.

Dunean McCarrum; name submission

The supporting documentation is illegible and incomplete as only
the page with the name reference was submitted a photocopy of the
title page of the source of this family tree is also required.

Taliesin of Carmarthen; name submission
There was no supporting documentation for this name and many
objections to the use of 'Taliesin'. It was suggested that there
has only been one 'Taliesin' in history and many magical and
divine events have been associated with him. It is also alleged
to be a title of the Welsh College of Bards.

## DOCUMENTATION

To provide documentation as supporting evidence for a submission, it is necessary to photocopy the title page of the document being cited and to photocopy all other supporting references in that document. Thorfinn Hrolfsson , Crux Australis Herald

Bryony of the Bees. Name and device. Per fess embattled argent and vert, three bees passant gardant counterchanged.

DISCUSSION: Bryony is a plant. "On a case-by-case basis we will allow the use of plant names as female given names. The basic criterion will be whether the College feels a specific plant name is reasonably consistent with period usage, even though it wasn't actually used in period." (WvS, 22 Apr 84, p. 3) There are, at this point, two registered instances of Briony and one of Briany; and there were no strong objections in the letters of comment.

According to Julian Franklyn, "These busy insects [bees] are in the displayed attitude whenever they appear, and the full term to describe them is volant en arrière: this may be shortened to volant; that they are flying away from the spectator being understood." (Shield and Crest, p. 132) Most of the flying insects registered in the SCA are seen from behind; they have been blazoned variously as volant, migrant, tergiant, and displayed (with variations). We found three examples of bees shown in profile — one "volant bendwise wings addorsed," one "statant bendwise," and one "statant close." We have blazoned this device on the model of the last two examples.

Gwynfor Lwyd

Resubmission to Kingdom, name and device.

Azure, a bar gemel couped and fitched argent between two frets couped and a chess pawn Or.

His previous submission was returned in June XX for clarification of the surname, along with a request for documentation on the given name. He has simplified the surname and did not provide the documentation. However, the name seems consistent with Welsh naming practice, so we have treated it as a made-up name.

If it is found unacceptable, he is willing to accept Gwynfyw, found in Early Welsh Geneological Tracts by Bartrum. Lwyd means "the Grey".

Johanna Wendover

New, name only.

Hendover is a town in Buckinghamshire.

Lochac, Crown Principality of

Name passed, herald's seal.

On a roundel, on a pale between four mullets, two and two, two straight trumpets palewise in fess, bells to base and chief.

This will be the seal for Crux Australis, the Principality Herald.

This was the second design. The first, "In fess an eagle displayed, head to sinister, and a lion rampant, each blowing a straight trumpet, the trumpets crossed in saltire in chief, within a bordure embattled", was judged to be too complex for a seal.

Merewyn della Fiore

New, name and device.

Per pale Or and sable, three lilies, stems conjoined, and in base two elm leaves, stems in saltire, counterchanged.

The given name is Welsh. The surname is Italian for "of the flowers".

Although the counterchange of skinny objects along their long axis has been disallowed, the "body" of the lilies is large enough that we feel that this will not apply.

Thorfinn Hrolfsson

Name passed, new badge.

(Fieldless) A demi-lion issuant from the lower half of a fleur-de-lys azure, maintaining a "thorn" rune sable.

This looked odd to us at first glance, but the more we looked at it, the better it seemed.

Agro Agwesi

New, name returned.

The submittor states that the name is "Japanese-European", but attaches no documentation. He gives as an alternate name "Ageru Akusei", but we do not know enough of Japanes naming practices to know whether this is a name either. We are returning it with a request for documentation.

Glynyhvar of River Haven

New, name returned.

The name is made-up Welsh, but is not correctly formed, since the element "glyn-" apparently does not appear in any Welsh names. She stated on her submission form that she really would like a Scots Gaelic name. A letter of consultation will be written.

In his LoAR of June XX, Lord Laurel announced some changes and clarifications of the Rules of which you should be aware:

- 1) Rule XII.12: "The addition of a single standard mark of cadency is not sufficent difference between an SCA badge and mundane or fictional arms." Lord Laurel has defined "standard mark of cadency" to mean: the standard English brisures (label, crescent, mullet, martlet, annulet, fleur-de-lys, rose, cross moline, octofoil), plain (uncharged and unmodified) chiefs, and plain bordures. Other methods of indicating cadency have been used, but they will not be consider under this Rule.
- 2) The FOINT-AND-A-HALF RULE: "Between two simple coats, difference in type of primary charge may contribute up to a major and minor point of difference." In order to apply this new Rule, the following conditions must be met: "1) In each coat, the primary charge must be the dominant part of the design. A complex field or a group of unlike secondary charges may detract enough from the importance of the primary to remove the extra minor point of difference. 2) The primary charges must be significantly different. Except in the simplest cases, they should probably be completely different. 3) The primary charges should not themselves be charged."

Vesper has decided that this Rule will be applied very carefully in the West until its limits have become clearer. For an example of how this Rule will be used in the West, see the discussion of the submission of Colwin of Oakwood in this month's acceptances.
