Greetings

The June meeting of the College of Heraldry met at the Shire Championship of Politikopolis on the afternoon of Saturday 15 of June AS XX, present were Thorfinn Hrolfsson, Crux Australis Herald, Diarmud ui Lorcaín, Acting Pursuivant Extraordinary for Politikopolis, Dafydd ap Donal ap Gwilym and Reynardine of Tara Pursuivants Extraordinary at Large. Next meeting on the First Teusday of July.

Fees have changed as is the will of the currency market with the current rate of exchange being 66¢ US for \$A1, if you do not like this rate please use something more upto date. Otherwise the fees equate to for :

SUBMISSIONS

Agro Agwesi; new submission for name and device:

Device: Sable, a bendlet twice bevelled, and in sinister chief a double bited axe Argent.

Conflicts with Adler des Berges - Sable a bendlet between an eagle displayed, wings inverted and voided and three mountain peaks chased and snow capped Argent (Major point for changing the secondary charge, a minor point for adding a secondary charge and a negligible point for changes to the bend).

Conflicts with Dagan du Darregonne - Sable, a lightning bolt bendwise Or, and overall a dexter gauntlet grasping a double bited axe Gules fimbriated Or (Major point for the changes in tincture, a minor point for adding the gauntlet and a negligible point for the lightning bolt instead of the bendlet).

The listed alternative does not significantly change the device and the twice bevelled bend is not a period (pre 1485) style.

Glynhyvar of River Haven; new submission for name and device: Device: Argent, a bend sinister Azure, surmounted by a lion's face caboshed Sable.

Conflicts with David of Cath Mawr - Argent, two lightning bolts issuant from chief Or, fimbriated and overall a natural panther's head caboshed sable, orbed Or and langued Gules. (Major point for changing the lightning bolts to a bend sinister, a minor to negligible point for the change of lion to panther and a negligible point for the details on the panther).

Johanna Wendover; new submission for name and device:

Device: Argent, on a fess Azure, between two trefoils slipped vert a rainbow Or.

Conflicts with Anne of Corbridge - Argent, a fess Azure, between a triple towered bridge and a tower Vert (Major point for a bridge and a tower instead of trefoils and a minor point for the rainbow).

Second choice: Argent, on a fess Azure, between two roses Gules, a rainbow Or.

Conflicts with Ruth of the Far North - Argent, in pale a brown bear proper sejant erect between two roses Gules, barbed and seeded proper (Major and a minor for changing a brown bear proper to a fess Azure charged with a rainbow Or).

Merewyn della Fiore; new submission for name and device:

Device: Per pale Or and Sable, three lillies slipped and cojoined and in base two elm leaves chevronwise inverted counter-changed.

No conflicts.

Bruci Anderson of the Shetlands: New name and device:

Device: Or, on a fess nebuly Azure, between four torteaux three and one each charged with a trefoil Argent, a gryffin segreant Or.

Possible conflict with Wake Papworth p718 referred to Vesper Principle Herald. Or, a fess, in chief three torteaux (Minor point for three torteaux instead of four, minor to negligible point for the addition of the trefoils and a minor point for addition of the griffin.

Crux Australis Herald seal of office.

Seal: In fess an eagle displayed head to sinister, and a lion rampant each blowing a straight trumpet crossed in saltier to chief, within a bordure embattled. Also three other designs.

Five names, two devices and a seal to be submitted to Vesper Herald on June 19.

Firiel of the Green Wood. Name only.

Morwenna of Oystermouth. Name and device. Purpure, a flute fesswise Or.

Reynardine of Lochac. Device. Vert, a fox's mask Or, a bordure wavy ermine.

The Lochac decision of Vesper Principal Herald

Agaricus, Canton of

New, name, device, and badge.

device: Sable, a laurel wreath Or between five mushrooms, two, two, and one, argent.

badge: Sable, two mushrooms in fess argent, caps conjoined and spotted gules.

Agaricus is the Latin word for "mushroom".

Jocelyn Holyer

Name passed, resubmission to Kingdom of device.

Or, a sprig of holly fructed proper within a torse wreathed argent and gules conjoined to four hawk's bells in cross gules.

The submitter believes that this torse and bell combination is termed a "jocelin", and wished the charge so called for canting purposes. The only reference we could find was to a charge of this appearance borne by the family Jocelyn (Elvin and the BIG Fox-Davies). We felt it would be better, in this case, to blazon the charge explicitly, just as it is in the Jocelyn arms. We also changed the hawk's bells from argent to gules to provide sufficient contrast to the field.

Her previous submission of "Gyronny argent and Or, an annulet wreathed vert and gules, conjunct to four sprigs of holly vert fructed gules" was returned in July XIX, as both the gyronny of two metals and the wreathing of two colors were not allowed.

Lleu ap Macsen

New, name only.

Lleu is a variant of *Llew*, and is found in Bartrum's Early Welsh Genealogical Tracts in both spellings. No one named *Lleu* seems to be associated with *Macsen Hledig*.

Marit the Wanderer

New, name only.

Marit is her mundane given name.

Sven the Stormdriven

Name pending, new badge.

Sable, a quill bendwise sinister within a bordure invected argent.

Torold of Hawkhurst

Name passed, resubmission to Kingdom of badge, see Returns for device resubmission.

Argent, a hawk displayed gules, on a base indented sable a hurst of pine trees argent.

This is more complex than we would like, but should be barely acceptable as a canting badge.

His previous badge submission of "Per bend sinister sable and argent, a shakefork counterchanged between a ram's head cabossed argent, a sword bendwise sinister proper, and a lion's head cabossed gules" was returned in February XVIII for complexity.

Torold of Hawkhurst

Name passed, device resubmission returned.

Sable chausse ploye and a ram's head cabossed argent, a bordure gules.

This was returned because the Rule of Tincture forbids putting a gules bordure on a device with a sable field. Also, although the device is intended to be a cant on his mundane surname of *Ramsbottom*, the large majority of those attending the meeting were immediately offended by the sexual connotations of the device upon being shown the picture with no comment. The remainder were offended as soon as the "joke" was explained to them.

His previous submission of "Sable chausse, a ram's head cabossed, its muzzle between two roundels argent" was returned in February XVIII for conflict, and for offensiveness.

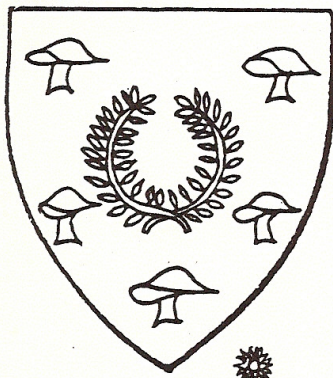

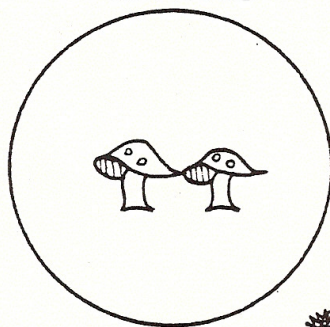

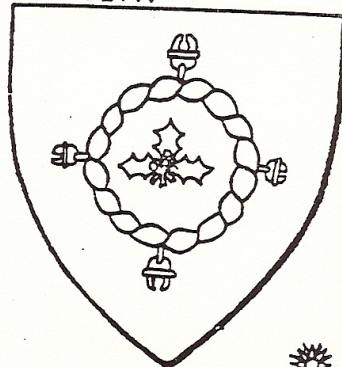

In his LoAR cover letter dated 8 May XX, Lord Laurel made the following change in the Rules of Submission.

"If two coats consist of different single charges plus a charged chief or bordure, difference in type of principal charge may count up to a point and a half. An additional minor point of difference in the charges on the chief or bordure would then make the two coats sufficiently different."

The West Kingdom interpretation of this Rule is that, for it to apply, the two charges must be completely different from each other visually, as well as by blazon.
