Salient Comments: The name seems documented well even if the sources seem somewhat related. The device however is not particularly good style as it is unbalanced having one fleur-de-lys to sinister and three sword to dexter but it is legal.

Commentary:

Harpy: All the variants of "Adeline" that I can find (in Withycombe and Reaney DES) have either "-a" or nothing at the end, but other names show variants of final "-a" regularly showing up as "-e" beginning in the 13th century, with a few A.S. examples as early as the 11th century (see, for example in Scott 1994: Avice, Aileve, Amice, Cecilia, et al.). Withycombe (p.4 under "Adeline") has examples of the spelling "Adelina" in the 11th and 13th centuries. Reaney DES (p.313 under "Montford" the submitted spelling "de Montford" in 1086. A very nice name!

Decision: Submit name and device to vesper.

Salient Comments: Well is there is a real problem with the system this time or is it the submitter. I am sure it is us. Stylistically there is a problem as there are six heads on this device really a semé is more than six but I don't think this is a problem, but I will think about it more.

Decision: There is no record of this anywhere. I hear rumours that she has submitted in a different kingdom using a different name. The only solution is to return for more information. Return Device.

Blazon: Sable in bend four winged swine statant argent.

Permitted name changes: The no name changes not even holding name box has been ticked. Important elements are meaning language and sound.

Permitted device changes: Whilst no box was ticked (tu tu tu) we have to assume that no changes are acceptable.

Documentation: Language is stated as Anglo-Saxon.

Haluin: p153 The Cadfael Companion - Robin Wakeman, After advice from Tangwystal it is constructed from the common protheme "Hal-" (Onomasticon -Anglo Saxon - Searle p 279) and "-uin" as a variant of the common "-wine". Harpy Herald cites "Britctuin" among others. The submitter provides photocopies showing "-win" on p499 ibid. At: is documented as the usual OE preposition for indicating residence. Eoforeslea: The "e" should have a line over it but I can't do that at the moment. This name is constructed as per OE naming practise from "Eofor-" (boar) (genitive -es) and "Leah" (wood) (dative Lea). Hence Eofoeslea meaning Boar's Forest. Photocopies are provided from Ekwall(p278,

160, 162) showing the elements.

Consulting Heralds: Rhyllian of Starfire Retreat, Pedair na Cluene Bige, Decion ap Drfwy Trfwy, Borfinn Herolfsson, Adrienne de Feilding Faux, Harpy

Salient Comments: The name looks very good and extremely well documented, and whilst the idea of fling pigs is a somewhat scary prospect, it should be perfectly acceptable.

Harpy: The protheme of the given name could come either from "Hal-" or "H<ash>l-" (found on neighbouring pages in Searle, ca. p.276-9). Note that "Eoforeslea" is the correct dative form to go after "aet" (see Ekwall's entry for "leah").

Decision: Harpy is quite right this name was submitted as Eoforeslea, I made a typo sorry. Submit name and device to Vesper, noting Politarcopolis' comment about saying out from underneath when I meet this gentle! Submit Name and Device to Vesper.

Consulting Herald: Wolfgang von Auerbach

Salient Comments: This name lacks documentation for the byname nor is any explanation for given this is not good, if you want the meaning retained please tell us what you think it means!

Harpy: Dauzat (p.312) lists the surnames "Guerre" and "Laguerre". I'd probably be willing to extrapolate to "de la Guerre". If someone (with much better French than I have) is willing to go through Dauzat with a fine-tooth comb, then you might be able to find parallel examples to support "de <activity>" - I just don't know. Morgan & Morgan (p.147) notes the spelling "Llewellen" as a surname in 1591. It's an English, rather than a Welsh, spelling, as the second "ll" is _not_ pronounced as Welsh "il". In my article on the names of 14th century Welsh mercenaries in France (see last year's Heraldic Symposium proceedings), I noted a number of names combining Welsh given names with French bynames, e.g., "Taheme le galoys" [Trahacam le Galois].

Decision: Reaney's D.O.B.S. sites a Peter le Werre /de Warre (under warre p 371) as dated to 1199/1203 and also site numerous examples of la Guerre. As warre and Guerre mean the same thing and seem to have to same original form (de la Guerre /Werre) I am willing to pass this name unchanged for those with better French experience and better resources, not to mention, other opinions to discuss them with.

The Device is not in conflict as Politichopolis states, there is one point for the change of the bordure to a chief and a further point for changing the type and number of the tertiary charges. Submit name and device

Consulting Herald: Wolfgang van Auerbach and the submitter.

Sallent Comments: The name submission is an interesting question as the submitter himself provides documentation that Strathclyde is a Kingdom and as such should be returned for presumption. It has been a long standing Laurel precedent that of <<Kingdom Name>> names are returnable as the imply that the person is the territorial owner and hence the King of that region. The question is whether Strathclyde is a significant enough problem? Also the device is coloured in pencil this is not good as a device last longer and is easier to see if it be coloured in ink. Wolfgang I apologise for the previous version of this statement. I was wrong! (I am good at that). It is however very pretty.(The device that is) Harpy: What is it with this spelling of "Llywelyn"? Has someone become convinced that this is the "correct" spelling or something? Regarding the following assertion: "It has been......King of that region." This is simply not true. The only problem (on the Laurel precedent level) is with names where the given name is also the name of a historical ruler of the region in question. (E.g.,

"Henry of England" is a problem but "Thomas of England" isn't.) Unless there were a ruler of Strathclyde named Llywelyn (which I seriously doubt, given that the Welsh were run out of that area back around the 7th century), this combination is not a problem.

Decision: I am fairly sure that my original statement still holds, but without the evidence I can do nothing but pass it on. I probably would have left it for my betters to decide anyway. Submit Name and Device

Blazon: Per fess Or and argent, two cats rampant sable and a rose proper. Permitted device changes: 1 Three cats rampant Sable, 2 rose Azure, barbed vert Seeded or. However no forms provided and as such they can't be officially considered. (Tancred!!!!!)

History: This Ladies name was registered in June 1992 and her previous device, Per fess Or and argent, two domestic cats rampant sable and a rose gules barbed and seeded proper was returned by Vesper in June 1993 for the Emblazon. This depicted the cats over lapping the line of division and also because they where grey instead of sable, ie It was returned for redrawing.

Consulting Herald: Tancred Enrico di Castrogiavanni

Salient Comments: This resubmission still hasn't dealt with one of the reason for it return that of the grey cats! The question is whether this is grounds for return of not. Also please, please remember if you want alternates you must provide a set of forms for each alternate.

Decision: As this submission has not fixed up on of the reasons it was specifically returned previously for, namely that the cats are coloured in silver not Sable and the blazon and states and contrast requires. I am returning this device. All that is required is for the submitter to contact me (or possible, I if I can.) to ensure that this is what the submitter is after and simply is mistaken, or if this is infact the picture she wants registered. (I remind people we register the picture not the blazon, and this picture in not registrable). Return Device.

Salient Comments: The name is correct and perfectly acceptable however it would be better if "de" was used instead of "of" because both of these element are from the Norman period of English history and hence the Norman indication of residence would be usual. There is no suggestion that it should be changed as it is legal as is. Please make submitters aware that in Norman English names it is better to use "de" instead of "of" but they can have either.

The Device is simple but has some stylistic problems firstly the chief needs to be much bigger and secondly it is added above the field not on top of it so the per saltire should meet the edge of the shield at the same place as the chief. Decison: The name is great and I pass it without reserve. The device has two problems one is the fact that the per saltire should meet the bottom of the chief and that the chief is in fact far too small. One of these faults on it own I would probably have let pass, but I feel both are sufficient to return this for redrafting.


